Morning Session

Leesa Scott-Morrow, PhD, JD, LP- "Ethical Thinking and Dealing with Difficult Patients"

Dr. Leesa Scott-Morrow has been a practicing psychologist for 25 years. Dr. Morrow was on the faculty at the University of Minnesota School of Dentistry, Division of TMD and Orofacial Pain, and currently sees patients in the neurosciences division at Health Partners in the Twin Cities. She received her Ph.D. in clinical health psychology and behavioral medicine from University of North Texas in 1990. After completing a degree in law at Indiana University School of Law in 2002, she has provided expert testimony in numerous trials and depositions, and has provided numerous professional continuing education seminars on bioethics and medical malpractice risk aversion.

Afternoon Session

Ioannis G. Koutlas, DDS, MS – "Oral Pathology Review"

Dr. John Koutlas is Associate Professor in the Division of Oral and Maxillofacial Pathology in the University of Minnesota School of Dentistry and Director of the University of Minnesota Oral Pathology Laboratory. He received his DDS degree from the Faculty of Dentistry, University of Athens, Greece, and trained in Oral and Maxillofacial Pathology at the University of Minnesota where he was also granted his Masters of Science degree. He is certified by the American Board of Oral and Maxillofacial Pathology. Dr. Koutlas has published multiple articles and book chapters in the field of Oral and Maxillofacial Pathology and has given lectures and seminars nationally and internationally. His special interests are soft tissue and bone pathology, odontogenic cysts and tumors and syndromes of the head and neck.
