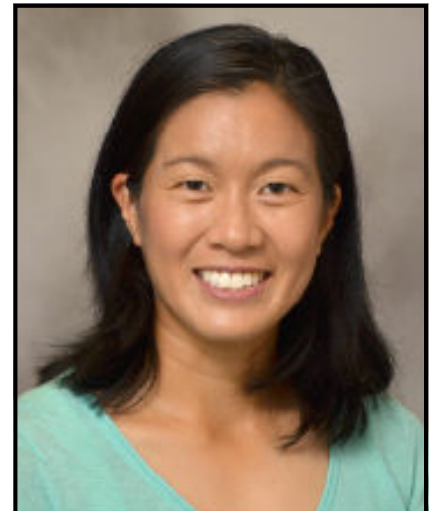

***“Upper Airway Stimulation: An Alternate Treatment Option for
Moderate to Severe Obstructive Sleep Apnea”***

Program Synopsis

Approximately 25 million adults as well as children in the U.S. have Obstructive Sleep Apnea (OSA) which can cause them to stop breathing hundreds of times a night anywhere from a few seconds to more than a minute. Untreated sleep apnea raises your patients risk for serious health problems including high blood pressure, stroke, heart disease, diabetes, chronic acid reflux and severe, untreated sleep apnea even increases your risk of death. Do you discuss (OSA) with your patients as part of their health history? How many of your current patients suffer from sleep apnea? Do you know where to refer your (OSA) patients for a sleep study and long-term treatment options? Did you know that CPAP and Oral Appliances can treat many of these (OSA) patients, but over 12 million are still seeking relief from (OSA)? Despite best efforts, several studies show that 50-60% of the current OSA population is not using or receiving benefit from standard medical treatment. This CE-accredited symposium will highlight Upper Airway Stimulation (UAS), an FDA-approved surgical option for treating the moderate to severe OSA population, as well as review scientific evidence for UAS including a review of clinical cases of recent UAS recipients.

Dr. Hsia's primary clinical interest is the surgical management and care of patients with Obstructive Sleep Apnea (OSA) and sleep disordered breathing. Dr. Hsia received specialty surgical training for the treatment of Obstructive Sleep Apnea during a fellowship at Stanford University. At the University of Minnesota, she is part of a collaborative team of specialists and works closely with the Department of Sleep Medicine. Dr. Hsia is a Board-certified Otolaryngologist. She did her residency training in Otolaryngology at the University of Washington in Seattle. Dr. Hsia is a surgeon who specializes in the most advanced new treatment method for (OSA) patients—Upper Airway Stimulation (UAS) therapy. This FDA approved procedure was developed right here in Minnesota and Dr. Hsia is performing some the initial implants at the University of Minnesota and HealthPartners.
