Our three presenters are periodontists representing over eighty years of periodontal practice involving more than 30,000 patients. Let them share their experience with you to help diagnose periodontal disease and offer suggestions for establishing or refining a periodontal disease diagnosis and treatment protocol for your office. What is working for you? What is not? How effective is your current protocol?

Discussion will touch on the subtleties of diagnosis and treatment of early to advanced periodontal disease, choosing cases for treatment, instrumentation and maintenance. Each periodontist will speak separately but there will be a panel discussion in the early afternoon where written (anonymous if desired) questions will be submitted by the audience and answered by the panel. Ask questions about antimicrobial treatment, evaluating success, recall frequency, sharing maintenance, laser treatment.

This is a program best attended by the doctor and the hygiene staff because the success of a perio diagnosis and treatment protocol is unlikely without the interaction of both professionals with the patient. If only one of the professions is involved, the patient is not getting what dentistry is capable of doing for them. It might be best said:

***Only the dentist attending*** = ***6 hours of CE credit for the dentist***

***Only the hygienist attending*** = ***6 hours of CE credit for the hygienist***

***The dentist and hygiene staff attending together*** = ***“PRICELESS” FOR THE PATIENT***
