CyberProtection (1 – 1.5 hours)

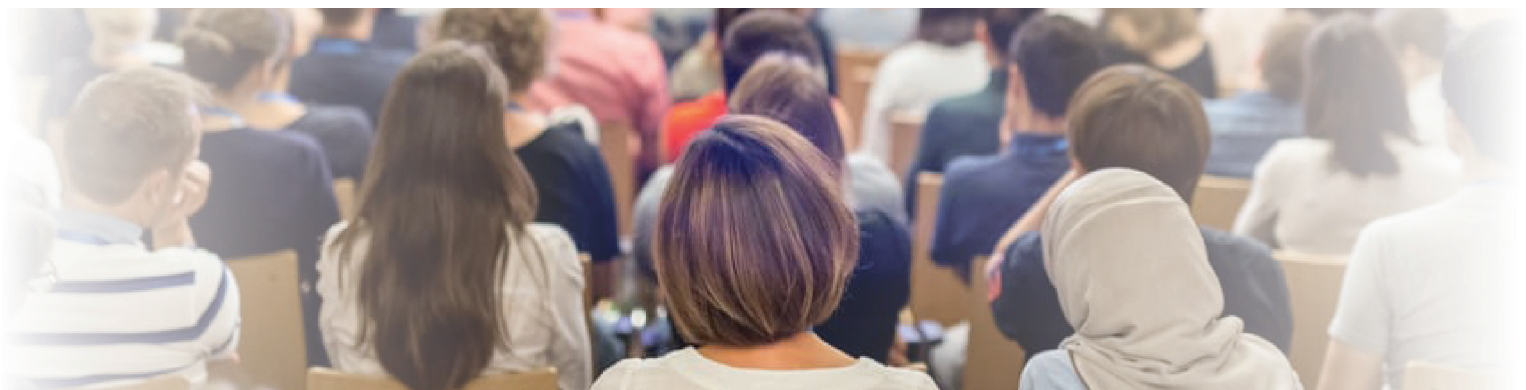
