**Featured Speaker: Ed Kusek, DDS-** "Implantology and Laser Assisted Periodontal Treatment."

Dr. Ed Kusek is going to provide us with a review of several areas of implantology that dentists can integrate into their modern dental practice, beginning with treatment planning cases, overdentures and attachments, as well as immediate implant placement and temporary options on implants. To segue into periodontal topics, Dr. Kusek will also speak about periimplantitis as well as laser-assisted periodontal therapy. We are excited to announce that with support from Straumann, Dr. Kusek will provide a hands-on segment for the dentists using models and dentures to practice converting a denture to a Locator-stabilized denture.

Dr. Kusek is a general dentist who enjoys being knowledgeable in the field of restorative and implant dentistry. He did his undergraduate work at Creighton University and received his DDS from the University of Nebraska College of Dentistry in 1984. He has practiced in the Sioux Falls area for about 30 years and began placing and restoring implants in 1987. He is a Diplomate of the American Board of Oral Implantology and holds several other titles of distinction, including Fellow of the American Academy of Implant Dentistry, Diplomate of the International Conference of Oral Implantologists, and Masterships in the Academy of General Dentistry, World Clinical Laser Institute and Academy of Laser Dentistry. He received a Life Long Learning and Service to Dentistry Award from the AGD in 2012, and has served as an adjunct professor for the University of South Dakota Dental Hygiene program. He is also a long-term member of the ADA, South Dakota Dental Association, and Southeastern Dental Society. He has been active in laser dentistry since 2004 and has published several papers on laser and implant related topics, as well as lecturing nationally and abroad.

Please also join us after the afternoon lecture for an informal reception to honor Dr. Ed McNiece on his retirement. Ed has been a long-time dentist in Worthington, as well as "jack of all trades" to the MDA and the SDDS.
